1. Studies at the Hebrew University Faculty Departments and the Rothberg International School

The Hebrew University Faculty Departments have decided to postpone the start of the Spring Semester to March 22, 2020, at which time all classes will be delivered online. To clarify, <u>all graduate and newly arriving students (exchange and external)</u> are advised that courses will begin on March 22, and will be delivered strictly online. There will be no in-class attendance until further notice.

The Rothberg International School's programs that are currently in progress will begin delivering all courses online effective Sunday, March 15, 2020. To clarify, <u>students in the Undergraduate Division as well as the Mechina and Sadara programs</u> should not arrive to the school for in-class participation, as <u>all classes will be offered strictly online</u>, at the same hour as their originally scheduled time-slots.

Courses will be delivered on Zoom's online platform. You will be sent a Zoom link through which to access your individual courses, and all lectures will be recorded and uploaded to Moodle. If Symptoms Develop

In case of fever (38° Centigrade/100.4° Fahrenheit or higher), coughing, difficulty breathing or other respiratory symptoms within 14 days from the time you left the above-mentioned countries, please dial 101 for the Magen David Adom (Israel's National EMS) Hotline as well as the Student Life emergency number: 054-8820217. Do not go to a medical clinic or ER. If necessary, a paramedic will be sent out.

3. Latest Updates Regarding Quarantine in Israel

The Government of Israel has implemented enhanced screening and quarantine measures for travelers arriving to Israel to reduce the spread of COVID-19. Effective Thursday, March 12, 2020, at 20:00 (Israel time), foreign travelers from all countries will be required to remain in home quarantine for 14 days from date of entry; non-Israeli residents will be required to prove they have the means to self-quarantine in order to be admitted into Israel.

For Israeli citizens and residents, the requirement of home quarantine went into effect on March 9, 2020. Hotels may refuse to honor reservations for individuals in quarantine.

Transportation options from the airport to any location may be limited. Restrictions are continually being updated by the Israeli government.

4. New regulations regarding entry into Israel, effective March 12, 2020:

The foreign national must contact their nearest Israeli Embassy via email to:

- 1. Explain the nature of your application, and declare that you have an accommodation arrangement in Israel, which is not a hotel or a dormitory (dormitories are currently unacceptable), but rather a pre-rented apartment, or a family member in-country that is willing to host you for the two-week self-quarantine.
- 2. Fill out an affidavit with the details of the apartment or the family who is intending to host. The affidavit will be sent together with the explanations to the consul, and from there, after the consulate's examination, to Israel for further examination. If the request is approved, a letter addressed for the applicant, which confirms that he can enter the country, will be provided to the consul.
- 3. One of the conditions for approving the application is that you will be collected from the airport by a private individual (not public transport, including taxi), who will meet you at the airport and will escort you directly to the apartment where you will be staying for the duration of your self-quarantine period.

It is very important to note that foreign citizens who do not receive permission from the embassy in advance will not be allowed to enter the country, and will be sent back to the country from which they arrived.

Individuals already in the country who were required to remain in home-quarantine according to previous instructions must continue to do so until the end of the 14-day period set at the time of their arrival in Israel.

5. Visits to West Bank cities of Bethlehem, Beit Jala or Beit Sahour

In addition, on March 9, 2020, the Israeli Ministry of Health instructed anyone who has visited the West Bank cities of Bethlehem, Beit Jala or Beit Sahour in the last 14 days to enter home-quarantine as per the <u>Israeli Ministry of Health's instructions</u>. This does not apply to those who have transited through those areas without stopping.

6. General Comments

- o Travelers should be prepared for travel restrictions to be put into effect with little or no advance notice. Travelers may be subjected to screening at airports or ports of entry. Flights into or out of Israel may be cancelled with little or no advance notice.
- Students who wish to travel outside Israel with the intention to return will not be able to reenter the country.
